It was requested that the Park issue a Resolution on a memorial for Tim Morgan.

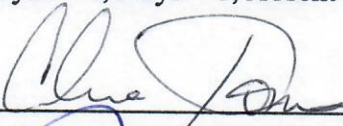
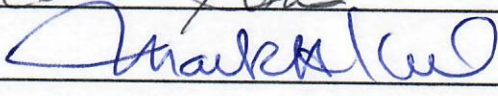
