JOB TITLE: Maintenance/Custodian FLSA CLASSIFICATION: Part-Time Employee DEPARTMENT: Maintenance IMMEDIATE SUPERVISOR: Maintenance Manager

### **POSITION FOCUS:**

Under the daily guidance of the Maintenance Manager, the Maintenance-Custodian position is responsible for performing the routine work involved in maintaining the parks and facilities. Maintenance-Custodian performs both indoor and outdoor activities. Outdoor environmental conditions will include but are not limited to heat, humidity, rain, etc. Maintenance Custodian will be exposed to pesticides, exhaust fumes, chemicals, dust, dirt, insect bites and loud noises. The Maintenance Custodian must be able to deal with multiple situations at the same time, while recognizing priorities of the department and the district. Maintenance Custodian is required to wear long sleeve shirts, pants, and work boots at all times while working.

# **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

- Under the general direct supervision and training of the Maintenance Manager, perform basic maintenance activities as follows:
  - litter pickup, garbage pickup, and recycling activities
  - cleaning and maintenance of park shelters, restrooms, and assigned buildings.
  - park maintenance (i.e., clean up and debris removal, mulching)
  - park maintenance at assigned parks (i.e., grass cutting, weed whacking, and edging)
  - maintenance of ball fields and tennis courts
- Demonstrate and support Park District customer service standards.
- Follow district and department safety, personnel, and administrative policies, procedures, and ordinances.
- Perform miscellaneous job-related duties as assigned.
- Ability to do minor preventative maintenance measures on all facilities, fleet, and equipment.
- Must be able to pass the OSHA 40-hour training as required by law.

# **QUALIFICATIONS:**

- Current First Aid/CPR certification or ability to attend mandatory training.
- Must be 21 years or older to operate park vehicles with valid Driving License
- Ability to work within a team structure.
- Ability to maintain self-control and composure in difficult situations.
- Endure physical components of frequent sitting, walking, reaching, and can be on your feet for extended periods of time. As well as being able to lift 50 lbs. (assistance is required when lifting less than 50 lbs.), occasional climbing, balancing, stooping, kneeling, and crouching.
- Employees may perform duties which include, but are not limited to prolonged lifting, stooping, bending, twisting, and climbing for extended periods of time.

- Have or obtaining, a high school diploma or G.E.D. equivalent.
- First Aid Certification and CPR Certification (Preferred)
- Understanding of indoor and outdoor maintenance and landscaping
